

Tips on advocacy and communicating with lawmakers

#### 2022 Regular Session: Just a Few Months Away!



As we enter the last quarter of the year, those involved with Hawaii's legislative process are increasingly aware that Regular Session comes right on the heels of the new year opening day is Wednesday, January 19, 2022. For advocates, that means it's not too soon to be talking with lawmakers about what you'd like to see happen next session. The time is ripe for drafting bills! The bill introduction deadline is usually just a week after session starts.

## Carryover Bills: Tips for Keeping an Eye on Them



Hawaii's legislature operates on a biennial (two-year) cycle beginning in odd-numbered years. What that means is that in even-numbered years, like 2022, the session starts out with all the bills that didn't move out of the legislature in the previous year still in the pipeline. These "carryover" bills will begin the new session wherever they left off the previous session. So, in addition to working on new bills that will be introduced, legislators can act on carryover bills if they so choose.

Although most often, no action is taken on carryover bills, you will want to know if one that you're interested in starts moving. If you signed up to receive hearing notices for a bill last session, it remains on your hearing notification list — so if it does gets scheduled for a hearing, you'll be among the first to know. You may want to double check your list to make sure that it's up to date. As far as your measure tracking goes, you may want to get a jump on next session by creating a new tracking list just for carryover bills. Label it (or rename the old one) "carryover bills." Then create another list for "2022 bills," which will keep track of newly introduced measures (empty for now). If one of the carryover bills does start moving, you can easily move it to the more active 2022 bills list. Need help? You know who to call! PAR is happy to walk you through it.
