


How to... Find Bills

Primary Search

HOW TO: Start at the Legislature's website capitol.hawaii.gov. Use the **Primary Search** box at the top right to search by bill number (HB100) to go to the bill status page, **or** search by keyword. Click on a result to get to the bill status page.

RESULTS:

- Option to **filter by content type** at the top of the search results page (*Measures, Hearings, Committees, Documents, HRS & Legislators*) or search **All Content**.
- Additional filters appear on the left and vary by content type.
- Filter by **year** (including multiple years) for content types of *Measures & Documents*.
- Content Type: **Documents** (includes measures, committee reports, testimony, GIA applications, session laws and more) and searches the full text of PDFs.



Primary Search (Measures) and Reports and Lists (Subject Search) only searches a bill's current title, keywords (report title) and description, not the full text of a measure or prior drafts. To search the complete text of a measure, including earlier versions of a bill or resolution, use Primary Search with the Document content type selected.

Subject Search

HOW TO: Start at Legislature's website: capitol.hawaii.gov.

- Click the **"Reports and Lists"** box (or select it from the **"Laws & Research"** tab).
- In the light-blue menu column on the left, click **"Subject Search"** (the last option).
- In the search box, enter the word or phrase you want to find.

Subject Search

Search Measure Number, Measure Titles, Report Titles (phrases matching a measure), and Descriptions of measures for the exact text entered.

Please omit diacritical marks (okinas and kahakos) from search words.

- Provides an organized results report, including descriptions, current status, and links to status pages and full content of bills (with PDF).

Find All Bills Introduced

NOTE: Change Year above **Deadline Tracking**

HOW TO: Start at the Legislature's website:
capitol.hawaii.gov.

1. Click on the [Reports and Lists](#) box (or select it from the **Laws & Research** tab).
2. On the right side of the screen, under **Deadline Tracking** you will find a section called **Measure Introduction**.
3. Click on the link you want to explore and browse the report.

RESULTS:

- Provides an organized report with descriptions, current status, and links to status pages and full bill content (with PDF).
- Allows you to browse the growing list of measures as they are introduced at the beginning of session (the bill introduction deadline is typically one week after Opening Day).
- Useful for building a thorough measure-tracking list.
- Refine search using your web browser's search feature (often keyboard: **Ctrl +F**).

Find Surviving Bills After Major Deadlines

HOW TO: Start at the [Legislature's website](#)

1. Click on the [Reports and Lists](#) box (or select it from the **Laws & Research** tab).
2. On the right side of the screen, under **Deadline Tracking**, scroll down to the most recent deadline, such as **First Lateral** or **First Crossover**.
3. Click the report links to view lists of measures that have survived the deadline.

RESULTS:

- Provides an organized report with descriptions, current status, and links to status pages and full bill content (with PDF).
- Shows bills that remain alive after major deadlines; the list of surviving legislation will shrink at each subsequent deadline.
- You may find bills that have changed significantly since introduction and are now of interest.

Results Report Hint: Click the **"Current Status"** column header **twice** to sort results by the most recent activity.
