DIGEST OF HAWAII STATE GOVERNMENT REORGANIZATION ACT OF 1959

Act 1 (House Bill 1) of the Second Special Session of the First Legislature of the State of Hawaii is the <u>Hawaii State Government Reorganization Act of 1959</u>. Its provisions recast the entire executive branch of the state government (except the offices of the Governor and Lieutenant Governor) into 18 departments. This action meets the requirements of Article IV, Section 6, of the State Constitution. Section 1 of the Act states that its principal purpose is to conform with the constitutional mandate, and Section 40 provides that immediate action taken under the Act will be limited to executive orders to "consist of a realignment of authority and responsibility in accord with the terms of this Act and need not necessarily involve ... detailed matter(s) related to the internal operation of any new department."

General Provisions

A number of major provisions of the Act concern matters other than the allocation of functions among the 18 designated departments. Among these are:

- 1. Section 5 regularizes the appointment and tenure of members of boards and commissions and terminates the service of all present board members on December 31, 1959 (except for members of the board of trustees of the employees' retirement system and the several county police and liquor commissions).
- 2. Section 6 defines the relationship between department heads and boards and commissions within departments.
- 3. Sections 7 and 8 assign the powers and duties of departments to the heads of those departments and further define the scope of administrative discretion vested in department heads.
- 4. Section 32 continues job tenure and status for employees.
- 5. Section 36 continues existing rights of appeal from administrative action.
- 6. Section 38 abolishes 63 agencies immediately and provides for the future abolition of four others.
- 7. Section 40 sets a schedule for reorganization such that: (1) Act 1 is to be substantially implemented by the first day of the 1960 legislative session; (2) certain aspects of Act 1 may be implemented on July 1, 1960 or the tenth day of the 1961 session; and (3) subdivisions and bureaus must be created not later than the tenth day of the 1961 regular session.

Specific Provisions

The organizational patterns created by Act 1 are depicted in Charts I through XX of this digest, and the effects of the Act on boards and commissions are summarized in Tables 1 and 2. All other specific provisions of the Act are summarized in the following paragraphs:

Section 1 states the purpose of the Act as accomplishing the constitutional mandate to organize into 20 or fewer departments. Recognizes joint legislative-executive responsibility for reorganization.

Section 2 provides that the Act may be cited as the "Hawaii State Government Reorganization Act of 1959".

Section 3 lists the 18 departments, as shown on Chart I.

Section 4 provides for appointment of single department heads by the Governor, for terms coterminous with that of the Governor. Requires senatorial consent to appointments and removals.

Section 5 provides for appointment of members of boards and commissions by the Governor, for four-year overlapping terms, and for a limitation of two consecutive terms for any such member. Terminates tenure of most present board members on December 31, 1959. Requires senatorial consent to appointments, but permits removal by the Governor for cause.

Section 6 defines the relationship between department heads and plural bodies placed within departments for administrative purposes. Vests department heads with powers and duties to: represent the bodies in communications with the Governor and Legislature; budget for expenditures; approve rules and regulations, personnel actions, and purchases; and allocate working space. Permits boards and commissions to: initiate budget requests, rules and regulations, personnel actions, and purchases; take full responsibility for any quasijudicial power they possess; and exercise any other powers not specifically reserved to directors by the provisions of Section 6.

Section 7 vests department heads with all powers and duties of their departments except as otherwise provided by Act 1. Gives department heads authority to promulgate rules and regulations for their departments, to assign duties to employees and, with approval of the Governor, to assign functions to subordinate units.

Section 8 places staffs of departments under the control of department heads.

Section 9 continues the constitutional assignment to the Lieutenant Governor of duties formerly performed by the secretary of Hawaii.

Sections 10 through 29 distribute functions of the state government to the 18 departments, as shown in detail in Charts II through XX.

Section 30 defines temporary boards and commissions and provides for their appointment.

Section 31 specifies the meaning of transfer of functions to the new departments.

Section 32 provides for transfer of personnel along with their functions, and enables employees with tenure to retain their positions and status.

Sections 33, 34, and 35 make provision for transfer of property, furnishing bonds, and continuity of actions at law.

Section 36 sustains existing rights of appeal from administrative actions by transferring appellate functions along with administrative duties. Provides for appeals to the circuit court whenever reorganization makes it impossible to appeal to new agencies.

Section 37 permits the Governor to assign any function to the department he deems most appropriate if such function is not allocated by Act 1. Makes exception in the case of police and liquor commissions, which shall not be assigned.

Section 38 abolishes most existing agencies other than those continued under identical names.

Section 39 provides for modification of the provisions of the Act by the Governor to the extent necessary to avoid jeopardizing federal aid or impairing bond obligations.

Section 40 establishes schedule of reorganization as follows:

- 1. By the first day of the regular legislative session of 1960 (February 17, 1960), the Governor is to appoint department heads and assign functions to departments by executive order.
- 2. In the cases of the University of Hawaii and the Department of Planning and Research, the provisions of (1) above may be delayed until the tenth day of the regular session of 1961, if legally necessary to permit present officers to hold their positions.
- 3. The provisions of (1) above may also be delayed until July 1, 1960 if the Governor informs the Legislature that special administrative or legal difficulties require such delay.
- 4. The budget for the 1960-61 fiscal year shall be prepared according to the new organization.
- 5. The Governor is to proceed with the internal organization of departments and submit bills implementing such organization to the 1960 and 1961 regular legislative sessions.
- 6. All aspects of the reorganization are to be completed by the tenth day of the regular session of 1961.

Sections 41, 42, and 43 provide for continuity of administration, amendment of conflicting laws, and separability of provisions.

Section 44 appropriates \$41,500 to the budget bureau and Governor for use in meeting the costs of reorganization. Sets a maximum salary of \$17,500 for department heads.

Section 45 provides that Act 1 shall take effect upon approval.

CHART I GENERAL ORGANIZATION PLAN OF THE EXECUTIVE BRANCH HAWAII STATE GOVERNMENT







ORGANIZATION FOR LEGAL SERVICES STATE OF HAWAII

ORGANIZATION FOR PERSONNEL ADMINISTRATION STATE OF HAWAII











ORGANIZATION FOR HIGHER EDUCATION STATE OF HAWAII





ORGANIZATION FOR MILITARY AFFAIRS AND CIVIL DEFENSE STATE OF HAWAII



ORGANIZATION FOR HAWAIIAN HOMES ADMINISTRATION STATE OF HAWAII






