

FOREWORD

This publication contains important information concerning the bills passed by the Hawaii State Legislature during the Regular Session of 2014, which adjourned *sine die* on May 1, 2014. This publication supplements the publication entitled "Bills Passed by the Hawaii State Legislature, Regular Session of 2014," which contains a brief description of each bill passed during the 2014 session and was issued by the LRB Systems Office in early May 2014.

This report consists of the following resources:

- (1) A preliminary index that contains a topical listing of the bills passed in 2014 under broad and general subject matter categories.
- (2) A table of "Laws Affected by Bills Passed" that shows sections of the Hawaii Revised Statutes, Session Laws of Hawaii, and the proposed constitutional amendments that are affected by bills passed by the Legislature during the Regular Session of 2014. It also includes a listing of new chapters of the Hawaii Revised Statutes. This table reflects information from the final draft of every bill passed by the Legislature.
- (3) A table of "Status of Bills Passed by the Legislature" that provides a listing of bills passed and includes the Act number, approval date, if any, and the appropriate committee report numbers.
- (4) A table of H.B. No. 1700, C.D. 1, Supplemental Appropriations Act of 2014,¹ furnished courtesy of the Tax Foundation of Hawaii, that shows the total program appropriations for fiscal years 2013-2014 and 2014-2015.

The foregoing information includes act numbers and approval dates for bills signed into law or vetoed by the Governor as of May 19, 2014. Information regarding any bills approved by the Governor after May 19, 2014, may be obtained through the Legislature's website at <http://capitol.hawaii.gov/>. The Governor has until July 8, 2014, to consider bills for approval.²

The "Supplemental Information" publication for prior years is available through the LRB Library website, at <http://lrbhawaii.org/>. Click on "Session Reports" under the "quick links" on the left-hand side of the screen to get to the "Legislative Reference Bureau Systems Office Session" reports page.³ Look for the heading "Supplemental Information Relating to Bills Passed" and click on the particular session year desired.
