

 - 3. Appear in every criminal case where there shall be a change of venue from the courts in the City and County and prosecute the same in any county to which the same shall be changed or removed.

- 5. Head: City and County Attorney.
- 6. How Appointed: Appointed by mayor for a term of two years.
- 7. Powers and Duties:
 - 1. Deputy of Attorney-General of Territory.
 - 2. Attend all courts of the city and county and conduct on behalf of the people all civil cases in which the city and county is interested.
 - 3. Appear in every civil case in which the city and county is interested where there shall be a change of venue and prosecute or defend the same in any county to which the same shall be changed or removed.
 - 4. Defend all suits brought against the city and county, wherever brought, prosecute all recognizers forfeited in the courts of record, assist the tax collector in the collection of delinquent taxes, and prosecute all actions for the recovery of debts, fines, penalties, forfeitures and other claims accruing to the territory or the city and county.

- 6. How Appointed: By mayor for term of four years—subject to confirmation and approval of four members of the board.

- 1. General supervision over all budgeting, financing, reporting, purchasing and accounting, and may prescribe methods and forms to be used, subject to statutory provisions.
- 2. Investigate the administration of the various departments and offices of the city and county for the purpose of recommending to the mayor and the board of supervisors concerning dubles, efficiency and such changes as will promote economy and efficiency.

 - 4. Attend and medically treat sick or injured prisoners in Honolulu jail or police station.
